at this year's World Championships in Berlin we would like to offer several events for breeders.

**1. Stallions Night:**

- the FEIF-ID of the horse that is likely to participate. It is free of charge to change the registered horse any time (information has to be sent to Linda by email [l.guth@isbev.de](mailto:l.guth@isbev.de)).

**2. Breeder's Corner:**

In a special area of the exhibition grounds we want to give companies, organizations, studs and individuals the opportunity to promote their breeding, products and services in a targeted manner and to present themselves to visitors interested in breeding. The idea of the Breeder's Corner is well known from the previous World Championships.

There are different exhibition options (plus VAT):

- 2.1. Stand 3x2 meters 800,- € incl. 2 access authorizations to the exhibition grounds
  - 2.2. Stand 2x2 meters 650,- € incl. 2 access authorizations to the exhibition grounds
  - 2.3. Exhibition board 2x2 meters with brochure display (daily replenishment by organizer) 400,- €
  - 2.4. Stand 3x3 meters 995,- € incl. 2 access authorizations to the exhibition grounds

## **Stallions Night at WM 2019 – Thursday, 08 August, 2019**

### **Official invitation:**

#### **Stallions Night at WM 2019**

Organizer: ISB e.V., Pariser Strasse 5, 10719 Berlin, Germany

Venue: Pferdesportpark Karlshorst (Treskowallee 159, 10318 Berlin, Germany)

Date: 08.08.2019

Arrival of horses: earliest possible from Wednesday, 07.08.2019, 12 noon

Departure of horses: latest possible on Friday, 09.08.2019, 11 am

Accommodation: Box in special area for show horses of WM 2019

Participating horses have to be properly liability-insured and vaccinated according to German IPO rules (same as for competitions, see [ipzv.de](http://ipzv.de) for further information). They must comply with rules and regulations set forth by veterinary authorities. All participating horses upon arrival will be subject to a vet-check according to FEIF and Berlin veterinary-authority guidelines.

Minimum age of ridden stallions/horses: 5 years

Registrations: Please use online form in the breeding category ("Zucht") on the German federation's website at [www.ipzv.de](http://www.ipzv.de). Due to a limitation of slots, entries will be accepted in the order received. For foreign participants it is also possible to register by mail to [l.guth@isbev.de](mailto:l.guth@isbev.de). Please send us your address data as well as the FEIF-IDs of the participating horses.

Package offer includes: six minutes ridden presentation time in the WM arena incl. individual advertising information on the big video screen, presentation in the printed WM program/magazine, free-of-charge display of flyers/brochures at WM info booths on 08.08.2019, horse accommodation (box) incl. feed for two nights, WM day pass for one person on Thursday, 08.08.2019.

#### Requirements for participation:

- Participants must be members of IPZV or of FEIF-affiliated federations
- Riders are required to wear helmets
- Participation in the event and accommodation of horses at own risk. Riders and horses are liable for damages according to § 833 BGB. All participating horses must be liability-insured for the duration of their stay at the WM venue. Riders and owners remain liable guardians of their horses during the entire stay of those horses at the WM venue according to § 834 BGB.
- Hosts, organizers, competition directors, show managers, ring stewards and head judges explicitly exclude all liability as far as legally valid.
- Participating horses must be free of infectious diseases and have to originate from a healthy stock. All horses need to be vaccinated according to current guidelines of FEIF.
- Horses' passports need to be presented upon arrival.



- The riders and owners of all participating horses commit by submitting their registrations to complying with all veterinary regulations and stipulations.
- Participation fees will not be refunded in case of withdrawal. However, the slot(s) may be handed to (an) alternative participant(s).

Participation fee: 500,- Euros incl. tax
